**2021 SWIMMING POOL RULES (Complete the signature lines at the bottom.)**

1. No person under the age of 18 will be permitted in the swimming pool area without being accompanied by their parent or guardian.
2. If guests are permitted, all guests must be accompanied by a Meetinghouse Resident over the age of 18 years old.
3. Parents or guardians are fully responsible for all persons under the age of 18 using the swimming pool facilities.
4. Parents are always required to accompany their children in the wading pool area.
5. All persons must shower before entering the swimming pool or wading pool.
6. All children in diapers must wear plastic pants with snug fitting elastic waist and leg fittings before entering the swimming pool. Parents MUST report any "accidents" to the lifeguard immediately.
7. All conduct that endangers the safety and comfort of others, such as running on deck, diving from shallow end, jumping or horseplay are prohibited within the pool area.
8. No person showing evidence of a communicable disease, bodily discharge, open blisters or cuts and bandages will NOT be allowed entry to the swimming pool area. Persons suspected of being under the influence of drugs or alcohol shall be prohibited from entering the swimming pool area.

9. No person experiencing diarrhea, or other gastrointestinal (stomach) symptoms will be allowed entry to the swimming pool area.
10. No animals will be allowed in the swimming pool area or restrooms.
11. No glass containers will be allowed in the pool area.
12. No swimming will be allowed during inclement weather conditions.
13. No smoking in or around the pool area.
14. Lifeguard on duty has complete authority within the pool.
15. Report all injuries to the lifeguard.
16. Appropriate swim attire required.
17. Follow CDC, Federal, State, and Local guidelines on social distancing and other safety precautions regarding COVID-19

Waiver – As pool patron and/or the parent or legal guardian of the pool patrons, I agree to the above pool rules and further agree to hold Owner/Agent/American Pool Enterprises Inc. and its subsidiaries and their officers free and harmless from any claim or expense that may arise due to my use of the pool or the use of the pool by dependents, guests or others residing with me.
